- 4. Live Agenda, Committee Chairs 7:25 7:50 pm
  - a. Finance, Gerrie Gerrie was not present at the meeting, however, there was some discussion on insurance costs and timing of payment. Jason said it has been challenging for ARC to find a policy that meets City of Seattle requirements. Last fall meetings were held with brokers, they were able to pull out the marine employer liability coverage making Green Lake slightly less expensive (Mt. Baker still paying due to navigability and location on Lake Washington).
  - b. Fund-Raising, Ideas:
    - 1. Paddle-a-thon or Erg-a-Thon May  $20^{\text{th}}$ ? Kids paddle or erg for a couple of hours often along with an open house. Look into donations via a QR code day of, and have money deposited to ARC.
    - 2. Garage sale.

Actions: Tami will explore donation logistics. Tami & Karla will discuss these fundraising ideas and events/dates (and race course set up March 12<sup>th</sup>) with coaches, parents, and paddlers. Karla will think about a good garage sale date.

- c. Sprint, Karla Next week is last of winter session, then short spring session before on-water practices begin. Meeting with coaches, and next Tuesday have parent meeting to discuss calendar, fund-raising, course set up, etc.

  Aaron and Andreea will be traveling to events this spring/summer, so Tami looking for another coach. Anna McGrory potential option.
- d. Regatta, ALL Next racecourse set up March 12<sup>th</sup>. Make sure we have enough boat drivers. Tami Discussed replacing line puller with Thor, want a 5 hp mounted on existing frame. Checking on electric motor options too. \$500 from each racecourse set up is put into a fund for course equipment and investment. Still need to have race/regatta download from Eric Hughes. Still need to discuss equipment replacements. Suggestions Lane buoys (200 per year for the next 2

years) and lines (2 line replacements are urgent for this year, then could come up with replacement schedule perhaps 2/year). John Cross-Whiter needed for this discussion and work.

Action: Steve will set up racecourse equipment replacement subcommittee with John

Action: Need to have Eric Hughes race download (incl Jared finish-line suggestions)

e. Boat House, Eli – Eli will be back in town next week. Tami gave report.

Construction project manager discussion needed about dark pathway between the road and containers behind aquatheater

Locks and adult member keys are for containers not aquatheater – will move some V7's into container for adult spring paddling

Megan Kelly can coach adults on Sundays. Eli would like to meet up with her.

Adult access to new boathouse, when should this be discussed? Jason said completion date is likely late Oct/early Nov. This is a good time because programs are going off the water, good time for outfitting boathouse.

Action: Need to set up subcommittee for boathouse access and outfitting issues. Will include dimensions confirmation and figure, coordination with rowing of moving into new boathouse, and outfitting boathouse. Subcommittee: Liz, Tami, Justine, Eli
